The above referenced Request for Quotation (RFQ) is amended to re-open and extend the closing date to 2 January 2015 and to include the installation of the following components in each vehicle:

- 1) Fiber Optic Gyro YAW heading sensor which will augment the existing compass.
- 2) An enhanced Acoustic Doppler Current Profiler and Doppler Velocity Logger capable of bottom lock at 0.5mm to 80m range and,
- 3) Iridium communications system for satellite data telemetry when IVER2 vehicle is operating on the sea surface.
